Conditions and Terms of Entry

1. CLOSING DATE FOR ENTRIES FOR ADVERTISING AND CATALOGUING is **12 noon on Wednesday 22nd May 2019**. PLEASE ENSURE ALL LARGER ITEMS ARE ENTERED IN ADVANCE TO ALLOW FOR ADVERTISING IN LOCAL PRESS AND ONLINE MEDIA.
2. No asbestos products, car tyres, window frames, household doors or white goods (e.g. fridges) will be accepted (except good quality tractor/landrover tyres).
3. **Entries will be accepted up to 4pm on Friday 31st May 2019** (except motor vehicles and motor cycles which must be entered by Wednesday 29th May 2019 and must be accompanied by the relevant log book). **NO ENTRIES ON SALE DAY.**
4. All lots must be delivered to the sale field between **9am and 4pm on Friday 31st May 2019**. ENTRIES WILL BE LOTTED IN ORDER OF ARRIVAL.
5. Free unloading facilities will be available on **Friday 31st May 2019** between **9 am and 12 noon only**, and free loading facilities will be available on **Saturday 1st June 2019 from 1 pm to 4 pm only**. Unloading and loading outside of these hours will be chargeable.
6. All items entered are entirely at the **owner's risk**. The Auctioneers accept no liability for loss or damage to any item. The sale ground will be secured overnight on Friday 31st May 2019.
7. In accordance with the **Low Voltage Electrical Equipment (Safety) Regulations 1989**, no electrical item can be accepted unless accompanied by a qualified electrician's certificate. Items that do not have such a certificate may be offered at the Auctioneer's discretion, however the plug shall be removed and the item offered for spares/scrap only.
8. All lots are sold '**as seen**' unless the Auctioneers are advised otherwise in writing.
9. Unless otherwise notified in writing on the entry form, all lots will be sold '**without reserve**'.
10. All lots will be sold subject to the Auctioneers' **Conditions of Sale**, which are available for inspection at the Auctioneers' office beforehand.
11. If a **reserve figure** is left on any item, it will be the responsibility of the vendor to check with the Auctioneer's office that the item has been successfully sold. PLEASE NOTE: No reserves shall be accepted for less than £10 per lot.
12. **All sold and unsold lots must be removed** within 2 hours of the close of the sale. Otherwise the Auctioneers reserve the right to dispose of the items as appropriate and invoice the cost of doing so to the Vendor.
13. **A lotting fee** of £2 will be charged on each lot entered.
14. **Tiered Commission** will be charged on each lot (minimum of £1 per lot) at the following rates: 15% on first £100, 10% on next £400 and 5% thereafter. Special rates are available for significant consignments especially tractors and good quality machinery and equipment.
15. **VAT** at the prevailing standard rate will be charged on lotting fees and commission charges.
16. Vendors will receive the **net sale proceeds** (excluding interest) within 14 days of the sale day.
