This Form Must Accompany All Cattle To Market (Please Read The Notes Over)

- 1. TB Test Dates:** Must be supplied (eg. One/two year test pattern or three/four year test pattern and date of test or days remaining).
- 2. Auction Lot Numbers:** Will be allocated by the auctioneers – see Declaration 2 and 2
- 3. Official Ear Tag:** This must be the complete number i.e. both sides of old tags, or full details of new tags – be especially careful with imported cattle.
- 4. Breed:** Initials are acceptable (eg. CH – Charolais, F – Friesian, LIM – Limousin, HO – Holstein, AY – Ayrshire etc).
- 5. Description:** Initials will do (eg. C – Cow, H – Heifer, Y – Youngstock)
- 6. Age/Date of Birth:** All calves (a calf is defined as being under 42 days) must have a date of birth completed. If available, this should be used for all cattle.
- 7. Vaccinations** – Please circle appropriate answer.

### Livestock Declaration

I hereby declare that animals included in the Lot Number(s) set out over comply with the following declarations:-

1. They have been kept to a standard of husbandry consistent with the DEFRA Code of Recommendations for the Welfare of Livestock
2. No substances (eg. Growth promoting hormones anti-microbials or B-agonists) are used illegally in rearing or finishing animals on the farm.
3. All cattle have come from premises, which has had no movement of FMD susceptible animals onto it in the previous 6 Days (other than permitted exceptions) or any signs of FMD or other notifiable diseases have been seen.
4. The movement complies with the relevant general licence.
5. Livestock sold for slaughter is warranted under the Food & Safety Act 1990 and is sold fit for human consumption, the vendor will be responsible for any rejected animals and costs occurred.
6. All movement comply with the relevant TB Regulations and vendors have checked the TB status of the cattle section before unloading.
7. No warranty over the effectiveness of any vaccination can be given or implied by either the vendor or the auctioneer.
8. All treatments must be declared by the vendor when presented for sale and withdrawal period notified.
9. All cattle must be accompanied with a correct BCMS issued passport.
10. No born cattle born before 1st August 1996 can be sold without being accompanied by an appropriate DEFRA Licence.
11. All feedstuffs for animals which are mixed on the farm do not contain:-
  - a) any approved substances above legally permitted maximum and/or
  - b) any substances which are used illegally
12. They have been fed only normal foods and are free from prohibited substances. No animal presented has been fed Protein derived from animal offal.
